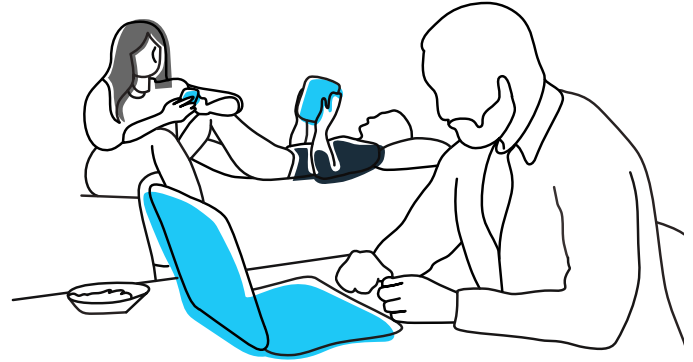


Get \$30 off per month Fast Home Internet with ACP

The federally funded Affordable Connectivity Program (ACP) offers \$30 a month off High-Speed Home Internet for qualifying households. Now everyone can get online at the same time for less. Those with Lifeline mobile benefits can also get ACP.



HOW TO APPLY

Step 1:

Check if You Qualify for the Affordable Connectivity Program

See if your household fits into any eligible categories.

Step 2:

Apply for the Affordable Connectivity Program

Choose how you want to apply and submit all necessary documents. Apply online at www.affordableconnectivity.gov or contact us for help at info@yzone.info.

Step 3:

Find a Broadband Provider Near You

Use the search tool everyoneon.org/cetf to find a company that offers ACP discounts. Prices for Internet service varies from \$10-\$30 a month which means after the discount is applied, Home Internet may be free.

Ask About Low-Cost New or Refurbished Devices!

For eligibility, someone in your household must be enrolled in at least ONE (1) of the following:

- Lifeline
- Free or Reduced School Lunch Program, CEP Schools
List of eligible schools are available in the application
- Pell Grant
- WIC (Women, Infants & Children)
- Or has a Household Income of \$55,500 or less for a family of 4 (add \$9,000 per additional family member)

Note: The Internet Service Provider cannot require a waiting period or charge market rate before applying the ACP discount.

The Yonkers Zone (Y-Zone), Y-Zone is paid for by the City of Yonkers through a New York State administered Community Development Block Grant under the CARES Act.

Frequently Asked Questions

Who is eligible for the Affordable Connectivity Program?

Participates in certain assistance programs, such as SNAP, Medicaid, Housing Choice Voucher (HCV) Program (Section 8 Vouchers), Project-Based Rental Assistance (PBRA)/202/811, Public Housing, SSI, WIC, or Lifeline;

- Participates in Tribal specific programs, such as Bureau of Indian Affairs General Assistance, Tribal TANF, Affordable Housing Programs for American Indians, Alaska Natives or Native Hawaiians, or Food Distribution Program on Indian Reservations;
- Participates in the Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture (USDA) Community Eligibility Provision schools.
- Received a Federal Pell Grant during the current award year; or
- Meets the eligibility criteria for a participating provider's existing low-income internet program.

Can I apply for the Affordable Connectivity Program if I have a past due balance with the provider?

Yes, eligible consumers with a past due balance or a balance in collections are eligible for the benefit.

Can I sign up for the Affordable Connectivity Program if I am already a customer or if I was a customer in the past?

Yes, the benefit is available to eligible new, prior and existing customers of participating providers.

If I already receive Lifeline benefits will I automatically receive the Affordable Connectivity Program?

No. You must opt-in with your existing provider or request enrollment in the Affordable Connectivity Program with a participating internet provider and choose an eligible service plan. You can choose to receive the benefit from your current Lifeline service provider or another participating provider.

I have children who attend the Yonkers Public Schools and receive free/reduced lunch automatically. Do I qualify?

Yes. Any household with a child attending the Yonkers Public Schools is eligible.
